DURING THE LAST YEAR SILOAM HAD 19,627 PATIENT ENCOUNTERS. IN ADDITION TO THE STAFF OF 39, 319 VOLUNTEER PHYSICIANS, NURSES, INTERPRETERS AND OTHERS CONTRIBUTED 13,057 HOURS OF SERVICE TO THE PATIENTS AT SILOAM. IN ORDER TO PROVIDE COMPREHENSIVE CARE, SILOAM ALSO CONNECTS ITS PATIENTS TO ITS EXTENSIVE NETWORK OF OFFSITE SPECIALISTS, HOSPITALS AND DIAGNOSTIC CENTERS THAT TREAT A CERTAIN NUMBER OF PATIENTS AT A SIGNIFICANT DISCOUNT OR WITHOUT CHARGE.
