

PRIMARY CARE CLINIC - SILOAM CARES FOR MORE THAN 5,000 UNINSURED AND UNDERSERVED IN MIDDLE TENNESSEE BY PROVIDING AFFORDABLE, WHOLE-PERSON CARE IN ITS 12,000 SQ FT FACILITY IN NASHVILLE. DURING THE LAST YEAR SILOAM HAD 21,101 PATIENT ENCOUNTERS. IN ADDITION TO THE STAFF OF 45, 380 VOLUNTEER PHYSICIANS, NURSES, INTERPRETERS AND OTHERS CONTRIBUTED 11,587 HOURS OF SERVICE TO THE PATIENTS AT SILOAM. IN ORDER TO PROVIDE COMPREHENSIVE CARE, SILOAM ALSO CONNECTS ITS PATIENTS TO ITS EXTENSIVE NETWORK OF OFFSITE SPECIALISTS, HOSPITALS AND DIAGNOSTIC CENTERS THAT TREAT A CERTAIN NUMBER OF PATIENTS AT A SIGNIFICANT DISCOUNT OR WITHOUT CHARGE. SILOAM'S COST PER MEDICAL VISIT IS APPROXIMATELY \$185. THE AVERAGE PATIENT PAYMENT IS \$23, BRINGING THE AMOUNT TO BE RAISED THROUGH DONORS AND GRANTORS TO \$162 PER VISIT.
