COMPREHENSIVE, WHOLE-PERSON MEDICAL CARE IS THE CORNERSTONE OF SILOAM HEALTH. OUR PRIMARY CARE CLINIC IN MELROSE AND WALK-IN CLINIC IN ANTIOCH PROVIDE CARE FOR THE UNINSURED THROUGHOUT MIDDLE TENNESSEE. OUR MEDICAL STAFF WORK ALONGSIDE 400+ VOLUNTEERS ANNUALLY TO PROMOTE THE PHYSICAL, SPIRITUAL, AND EMOTIONAL HEALTH OF PATIENTS FROM OVER 80 COUNTRIES, SPEAKING NEARLY 50 LANGUAGES. IN 2021, SILOAM SERVED OVER 6,000 PATIENTS AND CONDUCTED NEARLY 24,000 PATIENT ENCOUNTERS. SILOAM ALSO SEES NEWLY-ARRIVED REFUGEES FOR COMPREHENSIVE MEDICAL SCREENINGS REQUIRED FOR ENTRY INTO THE UNITED STATES. IN 2021, SILOAM WELCOMED OVER 800 REFUGEES THROUGH THIS PROGRAM.

OUR COMMUNITY HEALTH WORKER PROGRAM EQUIPS AND DEPLOYS TRUSTED INDIVIDUALS FROM LOCAL ARABIC AND SPANISH-SPEAKING COMMUNITIES TO ADDRESS PATIENTS' DAILY LIFE STRUGGLES AND NEEDS SUCH AS SOCIAL ISOLATION, MEDICAL MISTRUST, CHRONIC DISEASE MANAGEMENT, AND HEALTH CARE NAVIGATION.
