**COMPREHENSIVE, WHOLE-PERSON MEDICAL CARE IS THE CORNERSTONE OF SILOAM HEALTH. OUR PRIMARY CARE CLINIC IN MELROSE AND WALK-IN CLINIC IN ANTIOCH PROVIDE CARE FOR THE UNINSURED THROUGHOUT MIDDLE TENNESSEE. OUR MEDICAL STAFF WORKS ALONGSIDE 400+ VOLUNTEERS ANNUALLY TO PROMOTE THE PHYSICAL, SPIRITUAL, AND EMOTIONAL HEALTH OF PATIENTS FROM OVER 80 COUNTRIES, SPEAKING NEARLY 50 LANGUAGES. IN 2023, SILOAM SERVED OVER 6,800 PATIENTS AND CONDUCTED NEARLY 26,900 PATIENT ENCOUNTERS.
